PETITION FOR ACCESS TO PUBLIC RECORDS AND TO OBTAIN JUDICIAL REVIEW OF DENIAL OF ACCESS

TO THE HONORABLE CHANCELLORS OF THE CHANCERY COURT FOR THE TWENTIETH DISTRICT:

Pursuant to the Tennessee Public Records Act, T.C.A. §§ 10-7-501, et seq. to 10-7-505, ("Act"), Petitioner Alexander Friedmann petitions this Court for access to certain public records and to obtain judicial review of the actions of the Respondents in denying the petitioner access to those records. In support of such petition, Petitioner states as follows:

- 1. Alexander Friedmann (Petitioner) is a citizen of the State of Tennessee whose requests to exercise his right to obtain copies of public records under the Act have been ignored. Petitioner is also a Managing Editor of *Prison Legal News*, a nationally distributed publication that reports on news and litigation related to prisons, jails, and the criminal justice system.
- 2. Respondent, Tennessee Department of Correction ("TDOC"), is a Tennessee state agency that manages and operates fourteen prisons housing over twenty thousand offenders.

TDOC also supervises seventy-nine thousand offenders on probation, parole, or community corrections.

- This Court has subject matter jurisdiction of this petition, and venue is proper in this Court under T.C.A. § 10-7-505(b).
- 4. The Tennessee Public Records Act, T.C.A. § 10-7-501, et seq., applies to records "made or received" in connection with the transition of official business by "any governmental entity," which includes TDOC. See T.C.A. § 10-7-503(a)(1)(A)(i).
- 5. At all times pertinent to the request, TDOC, a department of the Tennessee state government, has operated or managed Tennessee prisons and/or jails. TDOC is a governmental entity subject to § 10-7-503.
- 6. Tennessee law provides that the custodian of a public record "shall promptly make available for inspection any public record not specifically exempt from disclosure." T.C.A. § 10-7-503(a)(2)(B). If it is not practicable for the record custodian to produce the record promptly, the custodian shall, within seven days, make the record available, deny the request in writing and state a basis for so denying it, or return a form to the requestor stating the time reasonably necessary to produce the record. T.C.A. § 10-7-503.
- 7. On July 17, 2019, Petitioner sent an Open Records Request pursuant to T.C.A. § 10-7-501, et seq., and in particular § 10-7-503, to Neysa Taylor, one of the employees at the TDOC, requesting the right to obtain copies of certain public records maintained by TDOC. (Exs. A, J).
- 8. The requested records are not exempt from disclosure under T.C.A. § 10-7-504(a)—(m). Indeed, TDOC has furnished Petitioner with similar records in the past. Ex. A at 2.

- 9. In violation of § 10-7-503, Petitioner did not promptly receive the requested records, a basis for denying the request, or a form requesting additional time to produce the requested records. See Exs. A (1)-(2), B.
- 10. As a result, Petitioner followed up via email with TDOC General Counsel Debbie Inglis to check the status of his request on September 11, 2019. Ex. C.
- 11. After Petitioner's initial follow-up did not receive a response, Petitioner sent an additional follow-up email to Ms. Inglis on September 18, 2019. Ex. D.
- 12. Petitioner also left multiple voicemails with Ms. Inglis in mid-September, which TDOC never responded to.
- On September 23, 2019, Petitioner sent a reminder of his request to another employee at the TDOC, Dorinda Carter, via email. Ex. E.
- Two days later, Ms. Carter responded that Petitioner could contact CoreCivic directly to obtain the requested records. CoreCivic is a private company that contracts with the TDOC to operate prisons that house state prisoners, even though Petitioner requested records in TDOC's possession and control, and Petitioner's public records request was made to TDOC, not CoreCivic. Ex. G.
- 15. Petitioner responded that the records he had requested in his previous requests were directed at TDOC, not CoreCivic, and the requested documents had always been under TDOC's possession and control. Ex. H.
- 16. Ms. Carter replied and said she understood and would get the records herself to deliver them to Petitioner. Ex. I.

- 17. However, by October 16, 2019, no records had been produced. Petitioner therefore reminded Ms. Carter of his request, and Ms. Carter responded that she was checking on the matter. Ex. J.
- 18. As of the date of this Petition, no records have been produced. Neither Ms. Carter nor anyone else from TDOC contacted Petitioner after October 16.
- 19. Petitioner's request was first submitted approximately four months ago. Petitioner has not received either the records, a denial of the request, or a form requesting additional time, which § 10-7-503 requires TDOC to produce within seven days of Petitioner's initial request.¹
- 20. The records that Petitioner is seeking are public records, and Respondent has no authority to refuse Petitioner's right to inspect or receive copies of the requested records.
- 21. The records that the Petitioner requested constitute public records under the Public Records Act. None of the exceptions to the act are applicable under these facts. Thus, TDOC's denial of Petitioner's access to these public records constitutes a willful violation under the Act necessitating the filing of the instant action pursuant to T.C.A. § 10-7-505, entitling the Petitioner to all reasonable costs and attorneys' fees.

¹ The Administrative Procedures and Regulations of the TDOC make clear that upon request, records shall "promptly" be made available to a requestor. According to these procedures, if it is not practicable for the record to be promptly available for inspection, the custodian must either furnish the requester with the records or deny the request in writing within seven days. Administrative Policies and Procedures: State of Tennessee Department of Correction, Tenn. Dep't of Correction 2 (2015), https://www.tn.gov/content/dam/tn/correction/documents/216-01.pdf. Here, however, several months have passed since Petitioner's initial request.

WHEREFORE, PETITIONER RESPECTFULLY REQUESTS THAT THIS COURT:

1. Issue an order requiring the Respondent to appear before this Court immediately,

or in no event later than ten days, and show cause, if any can be shown, why this Petition should

not be granted, as provided by T.C.A. § 10-7-505(b);

2. Grant Petitioner a declaratory judgment that documents in the possession, custody,

or control of Respondent requested by the Petitioner are public records under Tennessee law and

that Respondent's denial of access to these public records constitutes a willful violation of the

Tennessee Public Records Act, T.C.A. §§ 10-7-501 to 10-7-505;

3. Grant Petitioner his reasonable costs and attorneys' fees pursuant to T.C.A. § 10-

7-505(g); and

4. Grant Petitioner any such further relief to which he may be entitled.


