



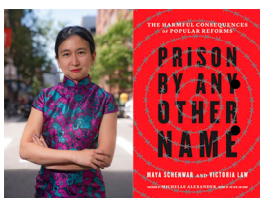

To celebrate 30 years of advocacy, we are hosting a virtual celebration on December 10, 2020 (International Human Rights Day) at 9:00 PM, EST.

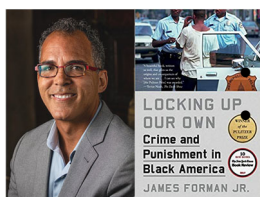
